### NOTIFICATION

Whereas, the draft of the following rules further to amend the Karnataka Shops and Commercial Establishments Rules, 1963 which the Government of Karnataka proposes to make in exercise of the powers conferred by Section 40 of Karnataka Shops & Commercial Establishments Act, 1961 (Karnataka Act 8 of 1962) was published in Notification No.LD 10 LET 2009, Dated: 07.12.2009 in Part-IV-A of the Karnataka Gazette Extraordinary, dated: 07.12.2009 as required by Sub-section (4) of the said Act, inviting objections and suggestions from all persons likely to be affected there by within 30 days from the date of its publication in the officials gazette.

And whereas, the said Gazette was made available to the public on 07.12.2009.

And whereas, no objections or suggestions have been received from the public.

Now, therefore, in exercise of the powers conferred by section 40 of Karnataka Shops & Commercial Establishments Act, 1961 (Karnataka Act 8 of 1962), the Government of Karnataka hereby makes the following rules further to amend the Karnataka Shops and Commercial Establishments Rules, 1963, namely:

### RULES

#### **1.Title and Commencement:**

- (1) These Rules may be called the Karnataka Shops and Commercial Establishments (Amendment) Rules, 2010.
- (2) They shall come into force at once.

2. **Substitution of Schedule-I** : In the Karnataka Shops and Commercial Establishments Rules, 1963 for Schedule-I the following shall be substituted namely:-
